

CHICAGO ACTUARIAL ASSOCIATION CLASSES FOR FALL/WINTER 2010 ACTUARIAL EXAMINATIONS

We have arranged review classes to help students prepare for selected actuarial examinations. The primary purpose is to aid students in reviewing syllabus material for the exams, with a lesser emphasis placed on introducing the topics to new students. The Associateship exams include much material that is common to the various actuarial disciplines. Thus, students preparing for actuarial careers may benefit from these classes.

It should be noted that some registrants might be eligible for reduced tuition. You qualify for the reduced fee if: 1) you are a full-time student; or 2) you are currently unemployed; or 3) you are repeating the equivalent class that was offered by the Chicago Actuarial Association within the past two-years. Proof of prior registration may be required for reduced tuition fees.
